- What are the risks involved with this approach?



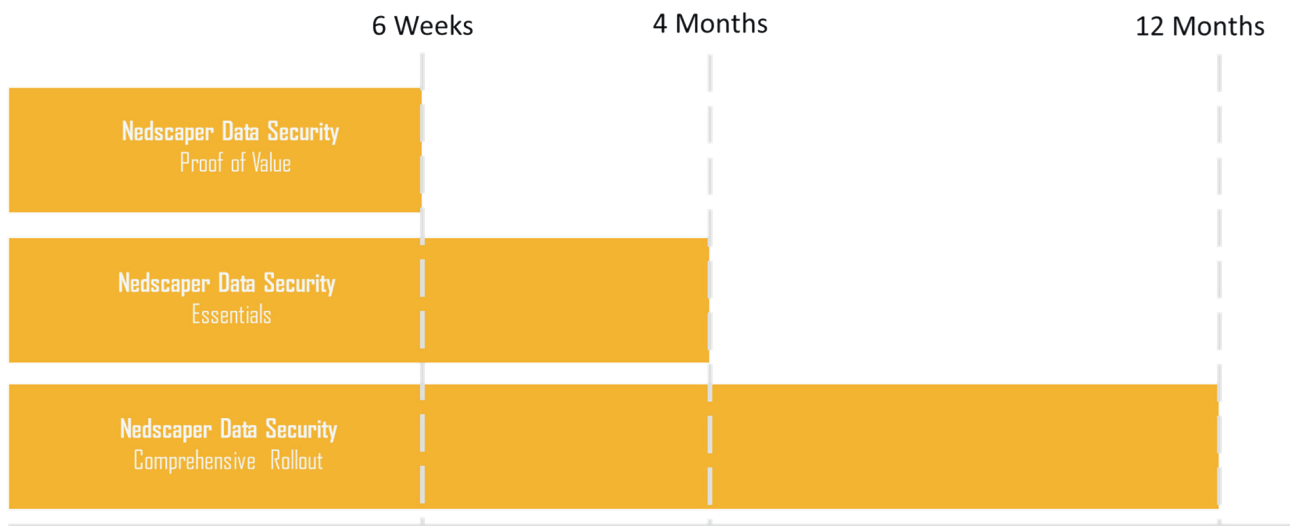

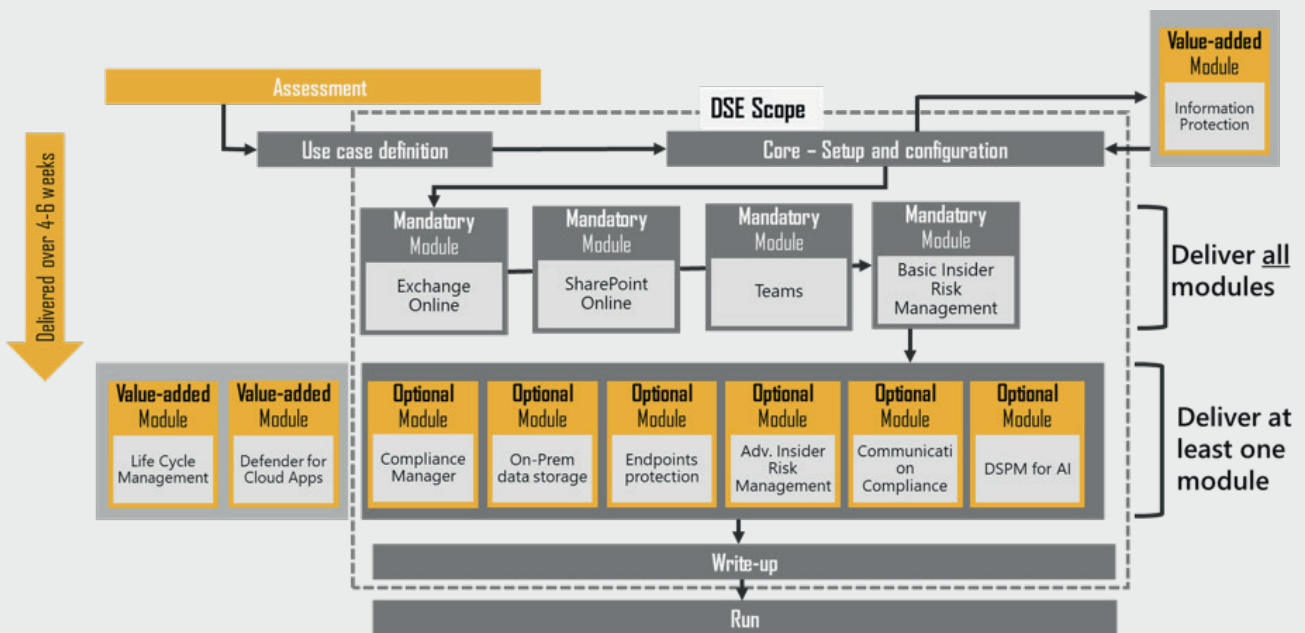
